For those of you who have been praying for my son's friend's mother, I want to say thank you and still continue to pray. Laura did not get a full release as had been hoped for but the ruling was not all bad. She was sentenced to a halfway house locally. She is not allowed back in her home but she does have so many hours per week where she can spend time with her husband and son. The organization has helped her get a job at the local goodwill store. She has expressed to me she really wants to come to church services but she can't come here because we are meeting in our home and one of the rules is that she

can't go to people's residences. There are a couple of ways we are trying to work around this. I have called the organization and inquired about the following:

- Could she attend services if they were held at a park?
- Is there a class or training I can take to get on the "approved places" list?

One of my best friends back home in Shreveport, LA called me last week to say that her daughter will be moving to Colorado. She will be living about 15-20 minutes away from us! She is looking for a fresh start in life and wants to know if it would be ok to come to church with us and help us in ministry! Please pray for Paxton and how God can use her and also for our family as we try to encourage and disciple her.

Continue praying for my daughter's friend Maddie Warren. After her attempt to take her life a few months ago, she is doing much better. Her and her family are attending therapy together and it seems to be helping! Her parents have made several lifestyle changes and are closely monitoring the friends she has. They have said they want her to continue being around Harlyn because she is such a positive influence on her. The mother and my wife have had several really good talks and seem to be bonding very well throughout this process.

The state of Colorado finally came out with guidelines for school and sports: Kids will be attending online only for at least the 1<sup>st</sup> month of this school year. Also, the beginning of football season has been moved to February of next year. I do understand the concern for safety during these unprecedented times but I am heartbroken for the physical and emotional toll this is going to have on the kids as well. We had just finished our summer football program and I was just beginning to establish good relationships with the boys. Now it will be at least early Feb of next year before we can all come together again as a team. I am constantly trying new ways to stay in contact with the boys, but it seems for every attempt, there is a new "legality" or "guideline" standing in the way. Please pray God will provide a way! These boys need their coaches and mentors in their lives!
